## North Central DUI Victim/Survivors' Panel Policies

Updated 11/27/23. Effective 1/01/2023

The North Central DUI Victim/Survivors' Panel is offered as a service to Okanogan County by the Okanogan County Community Coalition. To comply with State Laws, as well as to provide a safe an impactful experience for all, we hold the below policies:

- 1) You must provide the following at time of registration:
  - a. Photo ID State or Tribal issued.
  - b. Case Number you are attending under.
  - c. Name and Location of referring court. You may be asked to provide contact information for courts we do not regularly report to.
  - d. Payment in the form of Cash, Money Order or Credit/Debit card.
- 2) There is NO late sign-in allowed. Doors lock and Panel begins at 6:00 p.m.
- 3) Payment is due at time of panel. No late payments will be accepted.
- 4) If you are attending under more than one case number, you must pay the current registration fee for EACH case number.
- 5) You must be present for the entire panel to receive certification.
- 6) If you are under the influence of drugs and/or alcohol, you will be told to leave.
- 7) There is no food or drink allowed.
- 8) Phones must be turned off and put away. If you are on your phone, you will be told to leave.
- 9) If you cannot stay awake during panel, you will be told to leave.
- 10) If you are told to leave for any reason, you will not receive a refund or certificate. You will be required to pay again at the time of next attendance.
- 11) All attendees are required to sign in. This includes general public attending for free.
- 12) No children under the age of 15 allowed unless court ordered.
- 13) If you require a duplicate certificate and/or additional reporting, please contact us at least one week before you require said documentation. We cannot guarantee requests made less than a week ahead, can be fulfilled in time.
